FEE TABLE

1.0 ARTICLE II SECTION 5

Termination for non-payment \$50.00

2.0 ARTICLE II SECTION 7 E

Shutting off water at curb without authorization. \$75.00 per offense

ARTICLE II SECTION 7 G

Turn on and off at the curb stop by owners request for testing plumbing or other purposes: \$50.00.

ARTICLE II SECTION 7 H

For use of unauthorized or non-metered use of water from any connection to the District's water supply system.

- First Offense: \$250.00
- Second Offense: \$500.00
- Each subsequent offense increasing in amounts of \$250.00
- Broken meter seal \$50.00

4.0 ARTICLE II SECTION 9

Testing of backflow prevention devices: \$45.00 per test/per device.
Each additional test at same location \$35.00.

5.0 ARTICLE III SECTION 2

Entrance Fees

1.0 Residential

- A. Single family residence - \$5,000

- B. Multiple family residence (all structures containing more than one dwelling unit, where each unit is required that an individual service and curb stop be installed) \$5,000.
- C. Multiple family residence (all structures containing more than one dwelling unit, where the building is allowed to be on a single service and curb stop) \$5,000 per building and \$5,000 per living unit.

2.0 Nonresidential

- A. Entrance fee shall be based on size of meter:
 - 5/8 x 3/4 - \$5,000 (based on 20 gals/min)
 - 1" - \$12,500 (based on 50 gals/min)
 - 1 1/2" - \$ 25,000(based on 100 gals/min)
 - 2" - \$40,000 (based on 160 gals/min)
 - 4" - \$125,000(based on 500 gals/min)
- B. Entrance fee larger than four (4) inches shall be determined by the Commissioners.

3.0 Subdivisions, Secondary or Branch Mains

- A. Single family residential subdivision \$5,000 for each connection of the secondary or branch main or mains to the District's mains plus \$5,000 for each planned house lot (dwelling) served by the secondary or branch main. To be paid upon activation of service.
- B. Multi-family residential subdivision of \$5,000 for each connection of the secondary or branch main, or mains to the District's mains, plus \$5,000 for each living unit served by the secondary or branch main. To be paid prior to activation of service.

4.0 Commercial or Industrial

- A. \$5,000 for each connection of the secondary or branch mains to the District's Mains plus \$200 for each 100 linear ft. of secondary or branch main.

5.0 Fire Protection

- A. Separate service from the main for fire protection purposes.
 - 6" or smaller \$3,000 entrance fee
 - Greater than 6" \$6,000 entrance fee

6.0 ARTICLE III SECTION 8

WATER METERS

- 1.0 Installation of water meters 5/8 x 3/4 and 1" (included in entrance fee)
- 2.0 Meters larger than 1" - Cost of meter plus installation at District billing rate.

7.0 ARTICLE III SECTION 8

WATER METER TESTING

Owner request if meter is found to be running accurately (within 2%) within a three year period.

- First Call \$35.00
- Each Additional Call \$50.00

If meter is found to be faulty: No charge

8.0 ARTICLE III SECTION II

- H. Metered Hydrants - \$70.00/day plus water usage
- I. Fire Flow test - \$300.00/per hydrant test

9.0 ARTICLE IV SECTION 2

Contractors license Annual Fee \$50.00

10.0 ARTICLE V SECTION VIII B

Inspector's rate \$65.00
