FEE TABLE

ARTICLE II SECTION 5

- D. \$65.00
- F. See Article III, Section 2 Entrance Fees
- G. Termination for non-payment \$100.00

ARTICLE II SECTION 7

- E. Shutting off water at curb without authorization. \$150.00 per offense
 - G. Turn on and off at the curb stop by owners request, for testing plumbing or other purposes: \$65.00.
 - H. For use of unauthorized or non-metered use of water from any connection to the District's water supply system.
 - First Offense: \$1,000.00
 - Second Offense: \$1,000.00
 - Third Offense – termination of service and required to reapply
 - Broken meter seal \$100.00 if verified with previous records
 - I. For Non-essential water use
 - A. Residential Fees :
 - 1st Offense, written warning
 - 2nd Offense, \$500.00 fine
 - 3rd Offense, service shut off and \$500.00 turn on charge
 - B. Commercial Fees:
 - 1st Offense, written warning
 - 2nd Offense, \$1,000.00 fine
 - 3rd Offense, service shut off and \$500.00 turn on charge
- Fines for residential and commercial have a 30-day appeal to the board of water commissioners.

ARTICLE II SECTION 9

- D. Testing of backflow prevention devices: \$85.00 per test/per device.

- Each additional test at same location \$65.00.
- E. Cross Connection Survey \$100 per building, plus \$85 per device.

ARTICLE III SECTION 2

Entrance Fees

- 1.0 Residential 5/8 x 3/4 meter *to be paid at time of activation of service.
 - A. Single family residence - \$10,000 (one meter)
 - B. Duplex housing \$15,000 (one meter)
 - C. Condominiums - \$7,500 per dwelling unit (individually metered)
 - D. Multiple family residence (all structures containing more than one dwelling unit, where each unit is required to be on an individual service and curb stop) \$7,500 per dwelling unit.
 - E. Multiple family residence (all structures containing more than one dwelling unit, where the building is allowed to be on a single service and curb stop) \$5,000 per building and \$5,800 for each 1-2 bedroom unit, \$6,800 for each 3-bedroom unit, \$4,500 for each 4-bedroom unit.
- 2.0 Nonresidential
 - A. Entrance fee shall be based on size of meter:
 - 5/8 x 3/4 - \$10,000
 - 1" - \$28,000
 - 1 1/2" - \$48,000
 - 2" - \$68,000
 - 3" - \$200,000
 - 4" - \$400,000
 - B. Entrance fee larger than (4) inches shall be determined by the Commissioners.
- 3.0 Subdivisions, Secondary or Branch Mains
 - A. Single family residential subdivision \$6,000 for each connection of the secondary or branch main or mains to the District's mains, plus \$200 for each 100 linear feet of secondary or branch main. To be paid at the time of activation of service. (Does not include additional services or meter entrance fees)
 - B. Multi-family residential subdivision \$6,000 for each connection of the secondary or branch main, or mains to the District's mains, plus \$200 for each 100 linear feet of secondary or branch main. To be paid at the time of activation of service. (Does not include additional services or meter entrance fees)
- 4.0 Commercial or Industrial
 - A. \$6,000 for each connection of the secondary or branch mains to the District's Mains plus \$200 for each 100 linear feet. of secondary or branch main. To be paid at the time of application of service. (does not include additional services or meter entrance fees)
- 5.0 Fire Protection
 - A. Separate service from the main for fire protection purposes. To be paid at the time of application for service.

Grafton Water District -- Fee Table

6" or smaller \$3,000 entrance fee
Greater than 6" \$6,000 entrance fee

ARTICLE III SECTION 8

- B. Installation of water meters 5/8 x 3/4 and 1" - included in entrance fee
Meters larger than 1" - cost of meter plus installation at District billing rate.
- I. First Call \$150.00
Each Additional Call \$300.00

- E. Public fire hydrants \$150.00/year
- H. Metered Hydrants - \$150.00/day plus water usage
- I. Fire Flow test - \$300.00/per hydrant test
